

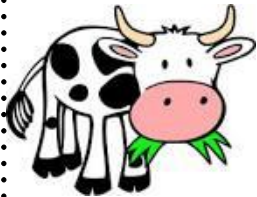
11th Annual Dairylicious Days Run/Walk

I understand and agree that this waiver/release is binding on my heirs, assigns, and legal representatives. 4) I understand that I am solely responsible for my health and safety, and I acknowledge that I am physically capable of participating in and completing the run/walk. 5) Should any portion of this waiver/release be judicially determined invalid, voidable or unenforceable, for any reason, such portion of this waiver/release shall be severable from the remaining portions herein and the invalidity, voidability, or unenforceability thereof shall not affect the validity, effect, enforceability, or interpretation of the remaining provisions of this waiver/release. 6) I have carefully read this waiver/release and fully understand its contents. If I am under 18 at the time of registration, my parent or legal guardian has completely reviewed this, understands, and consents to its terms, and authorizes my participation by his/her signature below. I am aware that this is a release of liability and a contract between me and the School District of Westfield. I sign of my own free will.
